

10th EDITION 2014

Cultural Association 'O Globo ONLUS publishes the tenth edition of **COFFI CortOglobo Film Festival Italy** that will take place on March 2015 in the historical halls of Doria Castle in the city of Angri - Salerno.

The Festival's official date will be published together with the program upon the deadline of the announcement on December 31st 2014 on the website www.coffi-de.it

Announcement of Competition

1. GENERAL

1.1 Competitive sections

Due to the high number of works, the festival board has decided to divide the works into two different categories. By doing so it has given the opportunity to professional and non-professional authors to confront themselves in a homogeneous category. Furthermore, this choice allows the Technical Jury to easily provide a more equal appreciation of the works. Here are the categories:

- -**Sguardi d'autore:** short films made by professionals of the sector. No thematic or genre limits. Time limit 15'.
- -Nuovi percorsi: independent authors with low budgets. No thematic or genre limits. Time limit 15'
- -**Spazio Scuola:** this one is dedicated to middle and high school students. No thematic or genre limits. Time limit 15'.
- -**Documentari:** Italian and foreign documentaries are allowed in this section in any genre and format. Time limit 40'.
- **N.B.** All works for each category must have both italian and english subtitles.

1.2 Preselection

All submitted works will be preselected by a Committee. The preselection passing will imply the admission to the finals. Only the selected works will be announced on our website (www.coffi-de-.it) under the heading "on contest". The works will be admitted to the finals according to the following evaluation parameters:

- To the admission at the section *Sguardi d'autore* the technical attributes will be gauged (direction, photography, editing, acting, soundtrack).
- In order to be admitted in the section Nuovi percorsi the works will be solely selected according to the plot' forcefulness. So outstanding technical qualities will not be necessary.
- In order to be admitted in the section Spazio scuola the entry-form must be followed by an informative documentation in which you have to write information about the purpose and the educational project on which the work is based.

when filling in the entry-form you have to indicate the category in which you want to compete. The selection Committee reserves the right move a short film to a different category in order to guarantee homogeneity in the categories. The contestants can stay informed about the selection of short films by visiting our website www.coffi-de.it. Here all the information needed will be published.

The selection Committee reserves the right to screen the works that have not been selected and therefore considered "out of competition".

1.3 Short Selection Mode

The selection Committee will choose a maximum number of twelve short films for each category. The decisions taken by the Committee are indisputable.

1.4 Jury

Two apposite juries have been established to comment the difference between the opinion of the review and the public.

1.4.1 Technical Jury

The Technical Jury (made by students, experts of the genre and professional workers of the audio visual field) will announce only one winner for each category in the competition.

1.4.2 Public Jury

The Public Jury will assign a score (from 1 point to 5) to a final short film among all the categories, through an evaluation form, according to their own personal choice.

Note: It is not possible to be part of both Juries. Moreover all the organizers and the ones responsible of the realization of the short films sent, are escluded. The decisions made by both juries are indisputable.

2. PRIZES AND AWARDS

The Technical Jury will award the following prizes:

Sguardi d'Autore: Prize of 500 € (or alternative prize) + award plaque Nuovi Percorsi: Prize of 250€ (or alternative prize) + award plaque

Spazio scuola: award plaque Documentari: award plaque

The Public Jury will aaward the following prize: Public Jury Plaque Award

The Association 'O GLOBO reserves the right to award a special prize for the most original idea to

any shorts on competition.

3. TECHNICAL ASPECTS

3.1 Partecipation

- The participation to the competition is free;
- those interested in participating in the competition must send the necessary material (see point 3.5) to the address written at point 3.6;
- each author is responsible for the contents of their works (see point 3.9);
- each author can send more than one work. It's up to the Committee choosing which work will be admitted to the competition among the ones sent;
- the participants will take on the expenses for the freight of the requested material;
- each participant must be sure to comply with every point of the settlement other it shall be excluded
- the participation to the competition involves the full acceptance of this regulation.

3.2 Admitted works to the competition

Works made in Italy or abroad will be able to participate in the competition after January 2012. We won't admit works submitted at the previous editions.

3.3 Format requested

The works must be send in a digital format on a DVD or link (esclusively VIMEO).

3.4 Requested material

In order to be admitted to the preselections you must send:

- 1 copy of the video in digital format;
- -1 entry-form (that you can download from the website www.coffi-de.it) signed in all its parts and sent with the video
- at least 1 photo of the short (jpeg format to sent to the e-mail address selezioni.coffi@gmail.com)

The absence of one of the items listed will not allow access to preselection. An informative sheet bout the short's director is welcomed.

3.5 Deadline

All the requested material must be sent within 15th December 2014 (postmark) to:

3.6 Protection claus

The Association 'O GLOBO is not responsible for packages damaged or delayed, or any theft or loss. Each author is personally responsible of the content of his work.

3.7 Privacy rights

The entry of a short involves the free availability (not exclusively) to the Association to use the work to purposes only related to the event, prior authorization by the appropriate space of the entry-form. The Organization will have without time limits rights of duplication, diffusion and utilization of the received products which will be used in nonprofit cultural and propaganda activities during the festival. Copies of the submitted shorts will not be returned but kept in the archive of the audiovisual section of the Association 'O GLOBO.

3.8 Copyright

The Association 'O GLOBO declines any responsibility due to the reproduction of short containing material covered by copyright which has not been regularized by the SIAE.

3.9 Privacy

All personal data collected by the Association 'O GLOBO will be treated according to the D.L.(Legislative Decree)196 del 30 June 2003 about privacy protection.

3.10 Other problems

For anything not expressely provided in the invitation the final judgement is up to the selection Committee.
