# CALL POP CORN FESTIVAL DEL CORTO 2019

#### **GENERAL REGULATION**

The Association Argentario Art Day, with the collaboration of artists and professionals in the industry and with the sponsorship of the Comune di Monte Argentario, promotes Pop Corn Short Film Festival, a short film competition open to all national and international video-makers. This year, all work must be guided by the theme: "Life: worth of a choice"

Registration: free Application deadline: April 20, 2019 Date of the event: 25-26-27-28 July 2019 Venue: Piazzale dei Rioni, Porto Santo Stefano, Monte Argentario (GR)

#### THE FESTIVAL INCLUDES TWO CATEGORIES:

**Corti d'Autore:** for professionals. **Opere Prime:** open to all the debut film makers. This category may also include collective works done by schools and associations.

#### EACH SHORT FILM MUST HAVE THE FOLLOWING CHARACTERISTICS:

Duration: up to 20 minutes, text and closing credits included.

**Theme:** All short films must adhere to the theme of "Life: worth of a choice" brought by the Festival.

**Language:** Italian, we agree to work in a foreign language provided they have an in Italian or English subtitles.

**Format:** accept all kinds of format, extension MOV, AVI, MP4, and all short films made with mobile phones, smart-phones, go-pro etc.

As for other media, exceptionally, the Festival reserves the right to decide, on the basis of operational requirements, to transfer them in a "normal ingest" way to an hard drive.

Short films also are already winners or participants to other festivals.

Each candidate may enter one or more works.

All works proposed for the Festival will be reviewed by the Artistic Jury, consists of a chairman and professionals, experts and scholars of film and theatre industries, the composition of which will be announced on the website *www.popcornfestivaldelcorto.it* 

#### **SELECTED SHORTS**

Candidates whose work will be selected to participate in the Pop Corn Festival on 25-26-27-28 July 2018 will receive an e-mail notification by 1 May 2019 and they will have to fill the Application Form sent to them.

#### ALL SELECTED SHORTS:

• should be sent via We Transfer platform **NO LATER THAN 20 MAY 2019**.

• supplemented by a list of dialogues in English and / or in Italian if in a foreign language.

• will have to be correlated with informative material such as: photo director, scene photo, poster of the short, synopsis, director biography etc.

All the material sent will be used to make the festival's catalogue.

The opinions emerged from the votes of the Technical Jury are final. The works presented may be Projected to the public in the manner and the programme established by the Organizing Committee.

Winners are requested to insert in the opening credits of the works awarded the logo of this Festival, along with the prize awarded.

Prizes will be awarded to the authors or their representatives who will ensure its participation in the award ceremony.
