# REGULATION

Associazione In-Oltre Onlus, in collaboration with Centro Studi Cinematografici, S.A.S. Bergamo, Cooperativa Sociale Namasté and Associazione Diaforà, organizes the second edition of CORTI SUL FILO DEL LIMITE – short film exhibition.

# THE THEME OF THE *LIMIT*

Will be awarded short films that are able to better develop the theme of **limit** within one or more of the different interpretation in which it can be placed. Among these we suggest some of particular interest:

- limit, confines and barriers, as structures that block (could block) possible encounters
- limit, confines and boundaries, places that separate (could separate) or put (could put) in relation
- limit, boundaries and limitations, conditions that dis-enable (could dis-enable)
- limit and link between diversity, differences and identity

It is an interpretation that is be suitable to articulated and complex looks, ranging from personal and existential to community, social and political levels.

The promoters emphasize that what was said above must be taken on as a starting point by the director/author, treated as a set of questions rather than as a thesis to defend: the director/author can and must freely develop his own point of view on the proposed theme.

# **REGISTRATION PROCEDURES**

- Short films with a maximum duration of 30 minutes (including opening and closing credits) in digital format can take part in CORTI SUL FILO DEL LIMITE competition.
- The competition is open and aimed at short films by national and international authors and productions.
- Short films of fiction, documentaries, experimental films and video art are accepted.
- The registration for the selection is free. Who wants to submit a film for the selection must send a link (protected with password and with the download option), accompanied by informative material about the film (synopsis, biofilmography of the director, at least two photographs of the film), regulation and entry form duly completed and signed, within 28/02/2019 to inoltrebgcorti@gmail.com
- For short films not in Italian it is compulsory to provide a copy with subtitles in Italian or English.

- The committee will select a maximum of six short films that will be screened during the event evening.
- The authors/producers/distributors of the selected short films will have to send the organization a screening copy in high quality (DCP, File Pro Res) by 15/04/2019.
- There will be awarded a Best Short Film Prize (€ 1,000)
- The Festival Jury reserves the right to also assign Special Mentions
- Cash prizes are considered for tax purposes "consideration of intellectual work, recognition of personal merit and title of encouragement" in accordance with Article 6 of the D.P.R. 430/2001

# **GENERAL RULES**

- 1. The Festival organizers reserve the right to cancel, suspend or modify the event if necessary.
- 2. The registration and acceptance of this regulation implies the authorization for the public screening of the short film in CORTI SUL FILO DEL LIMITE, which will be held at the Cinema Conca Verde in Bergamo in the second half of May.
- 3. Each author is responsible for the content of his work and assumes responsibility for the data he will communicate at the time of registration.
- 4. Associazione In-Oltre, promoter of the initiative, will be free to use the informative and photographic material provided to publicize the event through press, radio, TV, web, targeted posters, etc...
- Associazione In-Oltre, promoter of the initiative, is authorized to use and screen for free the short films proposed for selection in the context of related cultural initiatives. The organization undertakes to inform the director/author in the weeks before the screening.

# INFORMATION ABOUT DATA PROCESSING

Pursuant to regulation n. 2016/679 and of Legislative Decree no. 196/03, we inform that the Data Controller is Mr. Lucio Moioli, president of the Associazione In-Oltre Onlus.

The personal data acquired directly by the interested parties at the time of completing the registration form will be processed for the performance of the event, as well as for the pursuit of the purposes however connected and / or related to the participation and promotion in the Festival. The provision of personal data is necessary to be able to complete what is provided for in this regulation.
