

Competition Rules and Entry Form for Movie&Short Videoclip 2027

DEADLINE AND CALENDAR

- Final deadline for submission of the music video: October 31, 2026.
- Online voting period: November 15 – December 31, 2026.
- Winners announced: January 2027.

Participants must submit their works no later than October 31, 2026.

COMPETITION

Movie&Short announces the Movie&Short Videoclip 2027 competition. The theme is free. The competition awards the Best Music Video, selected by the online audience vote. It also awards technical prizes for Best Lyrics, Best Performance, Best Musical Composition and Best Music Video Direction. The technical prizes will be judged by a professional and technical jury, whose decision is final.

SUBMISSION PROCEDURE

To participate, visit www.dailybloid.com/movie-short-festival.

- Registration process: To ensure maximum security and legal compliance, participants must complete and sign the competition entry form and upload the required material.
- Entry fee: \$20.

INTELLECTUAL PROPERTY

The work must be original. The participant declares and guarantees that they hold all rights necessary for the work, including musical, lyrical and image rights. The participant agrees to indemnify the Organization against any claims by third parties, including any allegations of plagiarism. The Organization assumes no responsibility in the event of false declarations.

ONLINE AUDIENCE VOTING

Online voting will take place from November 15, 2026 to December 31, 2026 through the dedicated section of the magazine at www.dailybloid.com/movie-short-festival.

Each user may express their preferences according to the technical procedures established by the platform. Any attempt to manipulate the voting system or alter the results (e.g. bots or automated votes) will result in the immediate exclusion of the work from the competition.

The music video receiving the highest number of online preferences will receive the Audience Award and will be screened during the Movie&Short Festival 2027 event.

TECHNICAL JURY EVALUATION

During the final evening of the Movie&Short Festival 2027, to be held in May 2027, a qualified Technical Jury will award prizes for Best Lyrics, Best Performance, Best Musical Composition and Best Music Video

Direction, assessing in particular the originality of the lyrics and the overall quality of the work and performance.

The decision of the Technical Jury is final and not subject to appeal.

ANNOUNCEMENT OF WINNERS

The names of the winners (both the Audience Award winner and the Technical Jury award winners) will be officially announced on the festival website and social media channels at the conclusion of the voting and during the live event. During the live event in May, the winning works will be awarded and screened.

By participating, the participant grants Movie&Short the non-exclusive, free-of-charge and non-commercial right to screen, publish and distribute the music video for the promotional purposes of the Festival, including screening during the final 2027 event and publication on the official channels.

- The participant must pay an entry fee of 20 US dollars.
- Payment deadline: October 31, 2026.

VALIDITY OF THE ENTRY

Full payment of the \$20 entry fee by the established deadline is a necessary condition for the validity of the entry.

Submission of the work and online registration do not complete the entry in the absence of payment.

NON-PAYMENT

Failure to pay, or partial payment of, the entry fee by the established deadline will render the entry invalid and the music video will be excluded from the competition and selection process, unless an express exception or extension is granted by the Organizer.

Late payment does not automatically result in reinstatement.

ACCEPTANCE

I, the undersigned, have read, understood and accepted the competition rules and regulations, the entry fee, the payment deadline and the condition that failure to pay by the established deadline will result in exclusion of the music video from the competition.
