### "Tuscania in Short" Short Film Festival 5th edition 2025

At the start, the call for entries for the 5th edition of the short film festival "Tuscania in Corto" called by the Real Dreams cultural association of Tuscania (VT), **participation is free**. A unique showcase dedicated to cinema, the festival is organized under the artistic direction of Ludmilla Filippova and the organizational direction of Davide Boninsegna. Tuscania in Corto, wants to be a sign that

cinema however continues to exist and live, especially that of many small independent authors.

**Participation fee:** Free

**Expiration of the notice :** September 5, 2025

**Final awards evening :** November 08 2025

### **Three sections to apply for**

- **Free Theme Section**
- **Social and Environmental Section**
- **Women's Section**

### **Methods of voting:**

All short films submitted will be viewed by the festival management, which will select a maximum of 12 short films, 4 shorts for the Free Theme section, 4 shorts for the Social and Environmental section, and 4 shorts for the AI Femminile section. They will be viewed and

voted by juries; in the end, a sum of the votes taken by the juries will be made and the winning shorts will be announced on the evening November 08, 2025.

### Juries:

- Technical jury composed of directors and actors
- Special jury composed of the journalists

### Enrollment mode:

**Registration is free**, the call is open to works not exceeding 20 minutes in length including titles, each author may submit only one work. If the short film is in a foreign language, Italian subtitles are mandatory. **The deadline for submission of short films is**

**September 5, 2025.** The completed entry form should be sent to the Festival management at the email address :
